

FULL-TIME 3-YEAR *HIGHER NITEC* COURSES AND ENTRY REQUIREMENTS FOR JIE 'N'

Under JIE 'N', applicants may choose up to a maximum of 12 choices. Each choice will comprise the course and College, e.g. *Higher Nitec* in Accounting (3 years) course conducted at ITE College Central and *Higher Nitec* in Accounting (3 years) course conducted at ITE College East are taken as 2 choices.

The "2025 JIE 'N' ITE Aggregate Score" in the table below shows the ITE aggregate score of the lowest ranked students who were admitted to these courses through the 2025 JIE 'N', based on **best 4 GCE 'N' subjects including pre-requisites and bonus points**. These aggregate scores are meant as a reference for applicants applying to these courses and **do not** constitute the admission points for subsequent admission exercises.

Notes:

① For all courses:

- (I) The 3-year *Higher Nitec* courses comprise 3 months of Industry Attachment in Year 2 and 6 months of Industry Attachment in Year 3 except for Nursing which comprises 9 months of on-the-job clinical training.
- (II) As all ITE courses will incorporate online learning as part of lesson delivery, students will be required to purchase a Laptop. This is in addition to the course fees. Financial assistance is available to eligible students under ITE Opportunity Fund to purchase PC/Laptop subject to terms and conditions.

② In line with industry requirements, applicants for the following courses must ensure that they do not have colour appreciation deficiency: **Advanced Manufacturing; Aerospace Engineering; Applied Food Science; Architectural Technology; Automotive Engineering; Chemical Process Technology; Communications Design; Electrical Engineering; Electronics Engineering; Facilities Management & Engineering; Film & Video Production; Interior & Product Design; Mechatronics Engineering; Rapid Transit Engineering; Security System Integration; Technical Theatre & Production; Vertical Transportation and Visual Merchandising.** Colour vision test will be conducted for applicants enrolled into these courses. Colour Vision Test is available over the Internet at <https://for.edu.sg/cbt> and at the ITE Colleges conducting these courses. Please take the test before submitting your application if you are not sure whether you are free from colour appreciation deficiency.

③ All prospective healthcare students must be fully vaccinated against COVID-19 with a vaccine regime recognised in Singapore. Those who are Medically-Ineligible will be subjected to prevailing MOH and healthcare institutions' policies. Those who are medically-eligible but wish to remain unvaccinated may not be able to access the healthcare and community care settings to complete their Industry Attachment Module and meet the compulsory internship requirements necessary for graduation or their course completion may be delayed due to restrictions on internship posting to the industry.

Due to the special requirements of the healthcare profession and in the delivery of direct patient/client care, all applicants applying for 3-year *Higher Nitec* in Community Care & Social Services course have to pass a pre-admission medical examination and be free from physical and mental handicap to ensure suitability. Whilst not comprehensive, the following medical conditions will lead to non-acceptance into the course:

④ Eyecare practitioners are required to provide care, consultation and management of a patient's vision through eye tests and effective communication. Therefore, good interpersonal skills and good psychomotor ability is required. All applicants must possess the following abilities to perform direct eyecare on clients safely and effectively:

- **Mental-Cognitive ability**, including interpersonal-communication, emotional-behavioural stability to function under stressful work environment, and provide safe eyecare to clients.
- **Physical ability** to move around in a clinical/retail environment, including standing during service delivery.
- **Auditory ability** to communicate with patients under normal speaking level sounds.
- **Visual ability** to read small print on ophthalmic trial lenses and digital display on instruments.

Please refer to the Ministry of Health (MOH) website on "Fitness to Practice" for registered Opticians, stipulated by the Optometrists and Opticians Board. Interested applicants with impairment conditions highlighted by OOB are highly encouraged to contact ITE College East at college_east@ite.edu.sg for more information.

- ⑤ All prospective healthcare students must be fully vaccinated against COVID-19 with a vaccine recognised in Singapore and the stipulated vaccination regime required by the course. Those who are medically-ineligible will be subjected to prevailing Ministry of Health (MOH) and healthcare institutions' policies. Those who are medically-eligible but wish to remain unvaccinated may not be able to access the healthcare and community care settings to complete their clinical posting and meet the clinical training requirement necessary for graduation or their course completion may be delayed due to restrictions on clinical training.

All applicants applying for 3-year *Higher Nitec* in Nursing are required to comply with the 'Fitness Advisory for Nursing Students' stipulated by the Singapore Nursing Board at <https://for.edu.sg/fitness-advisory-for-nursing-students>, with the version as of August 2025 reproduced below:

FITNESS ADVISORY FOR NURSING STUDENTS

As the delivery of direct patient care is a requisite of healthcare professions, all applicants to pre-registration/pre-enrolment nursing programmes must pass a medical examination and be certified to have the following abilities to perform patient care activities in a safe and effective manner:

- 1) Mental-Cognitive ability (including interpersonal-communication ability and behavioural stability) to:
 - (a) understand and respond to verbal communications accurately, appropriately and in a timely manner
 - (b) possess awareness of one's surroundings to avoid causing harm to oneself and others
 - (c) demonstrate emotional stability to function under stress and pressure when performing care on patients
 - (d) remain calm when being observed by instructors and other health care personnel during clinical practice attachments
 - (e) maintain a sufficient level of concentration to complete tasks in a safe and reasonable time frame
 - (f) recall relevant information
 - (g) demonstrate the ability to perform arithmetic calculations
- 2) Physical ability to:
 - (a) move around in the clinical environment, walk, stand, bend, squat, kneel, reach, lift, climb, push and pull, carry objects, use both arms
 - (b) perform patient transfers
 - (c) operate and carry instruments, materials and equipment independently
 - (d) perform the necessary sequences of hand-eye coordination to carry out clinical procedures
 - (e) have the physical stamina to complete clinical shifts, including rotating shifts
- 3) Auditory ability to:
 - (a) detect faint body sounds (e.g. blood pressure, heart, bowel, lung sounds using a stethoscope)
 - (b) hear different types of auditory alarms and alerts (e.g. patient monitors, call bells, infusion pumps)
 - (c) hear and understand normal speaking level sounds in both quiet and noisy environments (e.g. person-to-person report, patient conversations, team communications)
- 4) Visual ability to:
 - (a) detect changes in physical appearance, colour and contour
 - (b) read medication/drug labels, markings on syringes, printed and written documents, coloured digital readings on medical/clinical devices and electronic health records accurately
 - (c) assess and describe colour, consistency and volume of bodily discharge and fluids

The above required abilities are stipulated in consultation with the Ministry of Health, Ministry of Education, and nursing schools (National University of Singapore/ Singapore Institute of Technology/ Nanyang Polytechnic/ Ngee Ann Polytechnic/ Institute of Technical Education), to ensure nursing students are fit to complete all components of the nursing programme and thereafter to apply for registration/ enrolment to practise upon graduation from the nursing programme.

Should applicants (i) have queries about the abilities outlined above or the following conditions that may affect their ability to meet the mental-cognitive, physical, auditory, or visual requirements, or (ii) are unsure if their condition(s) may affect their ability to deliver safe and effective patient care, please contact ITE College East at college_east@ite.edu.sg for further information:

- 'Physical health condition' includes (a) chronic medical illnesses or dermatological conditions (e.g. uncontrolled epilepsy, uncontrolled asthma, active tuberculosis, uncontrolled diabetes, uncontrolled hypertension, severe eczema on hands) which if associated with an exacerbation or with organ dysfunction complications, may hinder the applicant's ability to provide appropriate and safe clinical care, as well as (b) health conditions or its sequelae which restrict the applicant's subsequent ability to engage in safe clinical practice.

- 'Mental health conditions' refers to a range of conditions which are diagnosed and treated by a registered psychiatrist, and which may affect the decision-making ability of the applicant and compromise the well-being and safety of his patients/clients. These could include anxiety disorders, mood disorders (e.g. depressive and bipolar disorders), psychotic disorders (e.g. schizophrenia), neurodevelopmental disorders (e.g. intellectual development disorder, autism spectrum disorder, attention deficit hyperactivity disorder), as well as addictions.
- 'Other health conditions' refers to other conditions which may compromise the ability of the applicant to assess relevant information in order to formulate a management plan for his patient/client. This may include miscellaneous conditions for example dyslexia and other learning disorders, colour blindness or other conditions compromising the function of the applicant's visual and auditory senses.

Where applicable, the nursing school will advise or assist with regard to the necessary adjustments to support students with declared condition(s) to access the nursing programme while adhering to necessary requirements and standards.

- ⑥ Successful students will be required to purchase Training Materials (which will cost about \$400 for Beauty & Wellness Management, \$400 for Hairdressing & Salon Management, \$300 for Culinary Arts) for the course. This is in addition to the course fees. Financial assistance is available to eligible students subject to terms and conditions. Students can keep their materials at the end of the course.

FULL-TIME 4-YEAR *HIGHER NITEC* COURSES WITH ENHANCED FOUNDATION PROGRAMME AND ENTRY REQUIREMENTS FOR JIE 'E' INTAKE

ITE had introduced the **4-year *Higher Nitec* Courses with Enhanced Foundation Programme** for Singaporean/Singapore Permanent Resident Normal (Technical) holders with '0' or '1' GCE 'N' Level pass. The 4-year *Higher Nitec* Courses with Enhanced Foundation Programme begins with a Preparatory Year that will prepare students for Year 1 of the *Higher Nitec* course. Students who opt for the programme will spend a total of four years for a *Higher Nitec* course. In addition to the hands-on training, the programme will strengthen students' literacy and numeracy skills and improve their self-confidence and motivation. This will prepare them for lifelong learning and success.

Eligible GCE 'N' (Technical) students will receive a Form N with the list of courses they are eligible to apply for.

Under JIE 'E', applicants may choose up to a maximum of 4 choices. Each choice will comprise the course at ITE College Central or ITE College West, e.g. *Higher Nitec* in Retail & Online Business (4 years) course conducted at ITE College Central and *Higher Nitec* in Retail & Online Business (4 years) course conducted at ITE College West are taken as 2 choices.

POSTING OF APPLICANTS UNDER JIE 'N'

Different categories of 3-year *Higher Nitec* courses under JIE 'N' come with different entry requirements ranging from completed GCE 'N' Level to 3 GCE 'N' Level passes. GCE 'N' Level holders applying for admission to full-time 3-year *Higher Nitec* courses must first satisfy the entry requirements including passes in the pre-requisite subjects for the courses applied. Admission is merit-based, and posting to a course is based on **aggregate of best 4 GCE 'N' Level subjects, including pre-requisite subjects and bonus points** where applicable and is subjected to availability of vacancies. A lower aggregate point is indicative of better performance.

The computation of ITE aggregate points for Normal (Technical), Normal (Academic) and 'O' Level subject grades for merit-based ranking for admission to full-time 3-year *Higher Nitec* courses, is shown in the tables below:

The Normal (Technical) Grade E/U, Normal (Academic) Grade 6/U and 'O' Level Grade F9 will not be allowed to be used for fulfilment of subject-specific minimum entry requirements. However, these grades will be allowed to be used for aggregate computation for admission to full-time 3-year *Higher Nitec* courses.

CCA Bonus Points

The table below provides details for the computation of bonus points available. Please note that these bonus points are not taken into account when considering whether applicants are eligible for courses. The bonus points will only come into effect when the applicant has been deemed eligible and is being considered for posting based on merit.
